Bedbugs are becoming an increasing problem for housing providers across the country, and a number of assisted living providers here in Louisiana have already been battling these pesky pests. The elderly are particularly vulnerable to serious reactions from bedbug bites. Guest speaker Kyle Moppert, Medical Entomologist with the Office of Public Health, will provide tips for developing and implementing a bedbug prevention and eradication plan for your community. He'll share information on how to train your staff to spot signs of bedbugs, and provide you with a list of questions to ask your pest control provider in the event of an infestation.
