AN ACT

To amend and reenact R.S. 40:1300.53, relative to criminal history checks of licensed ambulance personnel or nonlicensed persons; to remove provisions which allow an employer to waive certain provisions; and to provide for related matters.

Be it enacted by the Legislature of Louisiana:

Section 1. R.S. 40:1300.53 is hereby amended and reenacted to read as follows:

§1300.53. Refusal to hire or contract; termination of employment; exemption; appeal procedure; waiver

A.~~(†)~~ Except as otherwise provided in R.S. 40:1300.52(C), if **no employer shall hire any licensed ambulance personnel or nonlicensed person when** the results of a criminal history check reveal that **any the** licensed ambulance personnel or nonlicensed person has been convicted of any of the following offenses, ~~the employer shall not hire or contract with such person:~~

(a) ~~(1)~~ Any crime of violence as enumerated by R.S. 14:2(B), R.S. 14:34.7, R.S. 14:35, R.S. 14:36, R.S. 14:37.1, R.S. 14:37.4, R.S. 14:38, R.S. 14:41, R.S. 14:43.3, R.S. 14:43.5, R.S. 14:52 through R.S. 14:54.4, R.S. 14:64.3, R.S. 14:64.4, R.S. 14:78, R.S. 14:80 through R.S. 14:83.3, R.S. 14:86, R.S. 14:89, R.S. 14:93, R.S. 14:93.3 through 14:93.5, R.S. 14:102.1, R.S. 14:282, R.S. 14:286, **R.S. 14:28.1, 30, 30.1, 31, 32.6, 32.7, 32.12, 34, 34.1, 34.7, 35.2, 37, 37.1, 37.4, 38.1, 42, 42.1, 43, 43.1, 43.2, 43.3, 43.5, 44, 44.1, 46.2, 51, 60, 62.1, 64, 64.1, 64.4, 66, 67.21, 89, 89.1, 93.3, 93.4, 93.5** or distribution or possession with the intent to distribute controlled dangerous substances as listed in Schedules I through V of the Uniform Controlled Dangerous Substances Act.

8 **B. Additionally, except as otherwise provided in R.S. 40:1300.52(C), no**
 9 **employer who provides care or services to any person under the age of twenty-**
 10 **one shall hire any licensed ambulance personnel or nonlicensed person when the**
 11 **results of the criminal history check reveal that the licensed ambulance**
 12 **personnel or nonlicensed person has been convicted of any of the following**
 13 **offenses:**

14 **(1) R.S. 14:44.2, 80, 81.2, or 93.**

15 **(2) An attempt or conspiracy to commit any of the offenses listed in**
 16 **Paragraph (1) of this Subsection.**

17 B C.(1) If the results of a criminal history check reveal that a nonlicensed
 18 person or any licensed ambulance personnel hired on a temporary basis or any other
 19 person who is an employee has been convicted of any of the offenses listed in
 20 Subsection A or B of this Section, the employer shall immediately terminate the
 21 person's employment.

22 (2) The provisions of this Subsection shall not apply to an employee or
 23 contract provider who has been employed for twenty-four months of the preceding
 24 thirty-six months, or a person who has received a pardon of the conviction.

25 C.(1) ~~The employer may waive the provisions of this Part, unless the licensed~~
 26 ~~ambulance personnel or nonlicensed person has been convicted of any crime as~~
 27 ~~enumerated by R.S. 14:31, 34, 34.7, 35.2, 37, 37.1, 37.4, 42.1, 43.1, 44.2, 64, 80,~~
 28 ~~81.2, 93, 93.3, 93.4, or 93.5. If the licensed ambulance personnel or nonlicensed~~

1 employer shall not hire or contract with such person and shall not grant a waiver to

3 ~~(2) A waiver may be granted for mitigating circumstances, which shall~~
4 ~~include but not be limited to:~~

5 ~~(a) Age at which the crime was committed.~~

6 ~~(b) Circumstances surrounding the crime.~~

7 ~~(c) Length of time since the conviction.~~

8 ~~(d) Criminal history since the conviction.~~

9 ~~(e) Work history.~~

10 ~~(f) Current employment references.~~

11 ~~(g) Character references.~~

12 ~~(h) Nurse aide registry records.~~

13 ~~(i) Other evidence demonstrating the ability of the person to perform the~~
14 ~~employment responsibilities competently and that the person does not pose a threat~~
15 ~~to the health or safety of patients or clients.~~

16 ~~(3) The granting of a waiver shall not be construed as creating an obligation~~
17 ~~upon an employer to offer permanent employment to such person.~~
